THE FINANCIAL SERVICES COMMISSION (FEES) ORDER, 2022

The Financial Services Commission, in exercise of the powers conferred on the Commission by section 44 of the *Financial Services Commission Act, 2010*, with the approval of the Minister, makes the following Order:

- 1. This Order may be cited as the *Financial Services Commission (Fees)* Order, 2022.
- 2. In this Order, "foreign currency permit" has the meaning assigned to it by section 2 of the *Foreign Currency Permits Act*, 2018 (Act 2018-44).
- **3.**(1) The fees set out in the *Schedule* are payable in respect of the matters specified therein.
- (2) The annual fee set out in Part I of the Schedule shall be paid by 31st January each year.
- (3) Where the annual fee is not paid by the time prescribed in subparagraph (2) there shall be payable, in addition to the annual fee, the late fee set out in the Part I of the Schedule.
- (4) For the purpose of determining a fee that is payable as a percentage of the total assets in any given year, total assets shall be calculated on the basis of the average, quarterly assets of the previous year.
