Impulse Shopping Mall Inc. - appointed Receiver by Republic Bank Barbados Limited (RBBL), to dispose of a 26-unit commercial complex located in Wildey, St. Michael, to repay the borrower's outstanding debt. Closed the sale in less than one year and above market value.
